



## RICHMOND CHRISTIAN SCHOOL (RCS) CONSENT AND ACKNOWLEDGEMENT OF RISK FORM – SECONDARY SCHOOL - ATHLETICS

The team will be transported to away games by an approved parent driver or an RCS employee.

It is important to remind each student to participate safely and abide by the expectations set out for them by Richmond Christian School. Students are to remain on site at all times and are not permitted to leave the area. Students are expected to behave appropriately at all times, given that they are a part of a team representing the school.

Students are responsible for their assigned team uniform (to be worn **only** for games). These are to be washed inside out in cold water with like colours and hung to dry. A replacement cost will be assessed to athletes who fail to turn in their uniforms by the given deadline or return a damaged uniform. Students are also responsible to have appropriate footwear in order to participate.

**CONSENT AND ACKNOWLEDGEMENT OF RISK FORM  
ATHLETICS**

Known Potential Risks may include but are not limited to the following:

- Injuries related to transportation risks (vehicle crashes) en route to and from the activity area;
- Injuries related to slips, trips and falls;
- Injuries related to collisions with movable or immovable objects;
- Injuries related to equipment malfunction;
- Concussions
- Injuries related to playing the above sport;
- Other risks normally associated with participation in the activity and environment.

Richmond Christian School will make every reasonable effort to ensure the safety of all athletic events. Staff are suitably trained and qualified and students will be properly supervised over all aspects of the program/activity. Parents and guardians are required to remind their children about the expected Code of Conduct and general rules of safety. If a student breaks the RCS Code of Player Conduct, parents may be responsible for the cost of sending the player home and/or the student may be suspended from the team. An Emergency Plan is in place to deal with an injury or illness and a Safety Plan is in place to manage known potential risks.

**RCS CONSENT FORM**

1. I acknowledge my right to obtain as much information as I require about this activity and associated risks and hazards, including information beyond that provided to me by the school or board.
2. I freely and voluntarily assume the risks/hazards inherent in the program/activity and understand and acknowledge that my child may suffer a potential injury arising from his/her participation.
3. My child has been informed that he/she is to abide by the rules and regulations, including directions and instructions from the school's representatives and/or administrators of the program/activity.
4. In the event that my child fails to abide by these rules and regulations, disciplinary action may require his/her exclusion from further participation, or I may be contacted to have him/her picked up.
5. I acknowledge that it is my responsibility to advise the Supervising Teacher of any medical and/or health concerns of my child that may affect his/her safe participation in the program/activity.
6. I acknowledge that the trip supervisors may secure emergency transportation to medical services as they deem necessary for my child's immediate health and safety, and that I will be financially responsible for such services.
7. I acknowledge that I have informed the supervising teacher of any medical or health concerns that may impact my child's wellbeing during this field trip. All necessary medication and updated instructions for its use have also been provided.
