# RESPONSIBILITIES

- 1. Support the campus leadership team in connecting and engaging with parents
- 2. Assist with the welcoming and 'on-boarding' of new families to RCS
- 3. Serve in a hospitality/welcoming role at special parent events that may occur at each campus. (Ex. Parent information and education evenings, concerts, etc.)
- 4. Support the development office with planned annual events and activities, which may include and be amended based on an annual needs review: (Ex. Welcome back BBQ, Teacher Appreciation Week, Grandparents/friends day, Pastor's appreciation events)
- 5. As needed, support the Principal in coordinating parent education events on current topics relevant to each campus.

# MEMBERSHIP

- 6. There are three (3) Campus Community Councils Elementary, Middle and Secondary.
- 7. The membership of each Campus Council shall consist of:
  - 1. The Campus Principal
  - 2. one (1) Board member;
  - 3. a minimum of (3) parent representatives;
  - 4. Other representatives as determined by the Council, which may include additional Administration or Staff.
- 8. The parent representatives must be a member in good standing of the Association.
- 9. The Board will select and approve the Board representatives.
- 10. The Campus Principal and Superintendent will select and approve the parent representatives. The Board will affirm the selections.

# **MEETINGS**

- 11. The Council will meet 4-5 times a year as follows:
  - a. Late August/Early September
  - b. November
  - c. 2-3 additional times as determined at a meeting of the council



- 12. The Campus Principal will Draft the tentative meeting agendas and share it with the Board representative for further input.
- 13. The Campus Principal will chair
- 14. The Board representative will submit the meeting minutes to the Superintendent and Board for information
